1. THE ACTIVITY

I am voluntarily taking part in an informal recreational shotgun event that includes launching and shooting biodegradable ClayCopter / clay targets; walking on uneven desert ground; heat and sun; other shooters; vehicles and OHVs; food and water service; and related travel on public land. Scoring is Hit or Miss over 12 rounds (up to 48 scored targets plus optional warmup). Any legal shotgun may be used. This is not an NSSA-registered skeet event and is not a supervised commercial range.

2. RISKS I ACCEPT

I understand this activity is inherently dangerous and can cause death, paralysis, brain injury, blindness, hearing loss, lead exposure, heat illness, broken bones, lacerations, and property damage. Risks include, without limitation: negligent or accidental discharge; ricochet and falling shot; defective or misfed ammunition or firearms; thrower malfunction; flying target fragments; other participants' acts or omissions; Host's acts or omissions including ordinary negligence; inadequate first aid; weather, dust, lightning, fire, and flash flood; venomous animals, cactus, and unstable ground; vehicle and trailer accidents on unpaved roads; contaminated soil or spent lead at historic shooting sites; foodborne illness from provided sandwiches or water; and rescue delay because cell service is unreliable. I KNOWINGLY AND VOLUNTARILY ASSUME ALL RISKS, KNOWN AND UNKNOWN, EVEN IF THEY ARISE FROM THE ORDINARY NEGLIGENCE OF THE RELEASED PARTIES or from hidden, latent, or unmarked hazards on public land.

3. RELEASE AND COVENANT NOT TO SUE

To the fullest extent allowed by Arizona law, I RELEASE, WAIVE, DISCHARGE, AND COVENANT NOT TO SUE the Host; any assistant, trapper, scorer, photographer, or volunteer; other participants and spectators; the United States of America, the Department of the Interior, and the Bureau of Land Management; and each of their family members, heirs, insurers, and agents (together, the "Released Parties") from any and all claims, demands, and causes of action for injury, death, or property loss arising out of or related to the Event, including claims based on the ordinary negligence of any Released Party. This release does not waive claims for willful misconduct or that Arizona law says cannot be waived.

4. INDEMNITY

I will DEFEND, INDEMNIFY, AND HOLD HARMLESS the Released Parties from any claim, including attorney fees and costs, brought by me, my family, my insurer, or anyone else, that arises out of my acts or omissions, my firearm, my ammunition, my vehicle, or my presence at the Event.

5. MY PROMISES

- I am at least 18 years old. If I enter the prize pool I am at least 21. I am not a prohibited possessor under federal or Arizona law.
- I will arrive and remain sober. No alcohol or impairing drugs until every firearm on the line is unloaded and cased. I will not handle a firearm if I have consumed alcohol.
- I will wear eye and ear protection on the line. I will keep the muzzle in a safe direction, action open until it is my shot, finger off the trigger until the target is in the air.
- I will obey the Host's range commands immediately, including CEASE FIRE. I will not shoot across roads, trails, camps, or into buffer closures. I will use a backstop and shoot only during daylight.
- I will pack out my hulls, unbroken targets, trash, and food waste. I will follow current BLM Table Mesa rules and Arizona fire restrictions. No exploding targets, tracers, or incendiary ammunition.
- I have my own medical insurance or I accept the cost of any care. Cell service may fail. Rescue may be delayed.
- I am physically able to take part. I will tell the Host about any condition that could affect safety.

6. MONEY, PRIZES, AND SUPPLIES

The \$40 cash I pay is an entry / supply fee, not a wager collected for the Host's profit. Documented event costs (targets, thrower amortization if used, water, food, electrolytes, ice) are reimbursed to the Host at cost from the entry fees. Any leftover cash after those documented costs is a prize pool paid 50% / 25% / 25% to 1st / 2nd / 3rd. The Host takes \$0 from the prize pool. If the Host also shoots, the Host competes on equal terms and may win a place prize like any other shooter. Unused unopened target packs are inventory for the next shoot, not income. I understand prize participation is optional, available only to persons 21 or older, and is a private social contest among the shooters. No refund after the first bird is thrown except at the Host's sole discretion.

7. MEDICAL CONSENT

If I am hurt and cannot decide for myself, I authorize the Host and any first-aid provider to arrange emergency care. I accept all cost of that care. I have listed an emergency contact below.

8. PHOTOS AND NAME

I give the Host permission to use photos or video of me from the Event on the Dust Devil website, group texts, and printed cards. I may opt out by checking the box in the signature block.

9. LAW, SEVERABILITY, WHOLE AGREEMENT

Arizona law governs this agreement, without regard to conflict-of-law rules. Exclusive venue is the state courts of Maricopa County, Arizona. I waive any jury trial to the extent allowed. If a court strikes any sentence, the rest still stands. This is the entire agreement about liability for the Event; it covers this date and future Dust Devil dates at Table Mesa unless I sign a newer form. I am not relying on any promise that is not written here. Headings are for convenience only.

10. I HAVE READ THIS

I have had a chance to read this slowly and to ask questions. I am signing of my own free will. I understand I can choose not to shoot. I understand this document is a legally binding contract.
